



Run The Spelling and Grammar Checker Manually

To start a check of the spelling and grammar in your file just press F7 or follow these steps:

If the program finds spelling mistakes, a dialog box appears with the first misspelled word found by the spelling checker.

SOLDIERS KEPT WATCH THROUGH A RARE BLIZZARD AT THE TOMB OF THE UNKNOWN SOLDIER

Monday morning saw the Washington, D.C. area receiving a rare blanketing of snow, ranging from 5 to 10 inches in some locations. For the sentinels who stand guard at the Tomb of the Unknown Soldier in Arlington National Cemetery, 24 hours a day, 365 days a year, that meant some less than stellar duty conditions.

Photographs showed the guard detail of the 3rd U.S. Infantry Regiment, known as the Old Guard, marching amid the heavy snowfall in front of the Tomb, the final resting place for unknown service members killed during World War I, World War II, and the conflicts in Korea and Vietnam.

Dedicated on Nov. 11, 1921 by President Warren G. Harding, the Tomb was <u>established</u> in the aftermath of World War I to honor American soldiers who, as the Tomb's inscription reads, remain "known but to God."

Guards were first placed at the Tomb during the day five years later, in 1926, "after one too many tourists had used the grave as a picnic table," according to an Army news release. In 1937, guarding the tomb became an around-the-clock duty, and in 1948 the Army designated the Old Guard as the ceremonial unit tasked with performing said duty.

Maintaining the vigil in any and all conditions is part and parcel of the rigorous training that the Tomb guards undergo before they assume their duty as a sentinel. For six to nine months, guards complete a training regimen that includes marching, uniform preparation and the study of military history. Guards often train for their ceremonial duties in the middle of the night, when the Tomb is closed to visitors.

"You do training during the day...manual, uniform, uniform classes. And then at night, you get your hours of training in," Staff Sgt. Kevin Gilliam <u>said</u> in a 2010 Army news release. "The guards who are posted at night aren't a ceremonial guard. They're in [Army Combat Uniform]. So they're working on walking the mat, perfecting

their lines, angles. We also do training as a whole. The whole squad will go out at night and train the guard changes and things like that."

Bad weather is often to be expected during a shift. As the creed of the Tomb guards says, they are expected to march and perform their duties through "the discomfort of the elements." That applies even during snowstorms and other extreme weather conditions.

In the case of, say, a hurricane, the Tomb guards may have some brief respite.

"The Tomb Guards have contingencies that are ready to be executed if the weather conditions ever place the soldiers at risk of injury or death (i.e. lightning, high winds, etc)," reads the guards' contingency plan for extreme weather conditions. "This ensures that sentinels can continue the mission while ensuring safety. It is the responsibility of the chain of command from the sergeant of the guard to the regimental commander to ensure mission accomplishment and soldier welfare at all times."

In 2011, when Hurricane Irene made landfall near the Chesapeake Bay, a spokesman for the Old Guard told The Daily Beast that, if necessary, the guards would move to a small enclosure nearby. They would, however, always remain within sight of the Tomb itself.

Service members in ceremonial roles have a long history of braving the elements and maintaining their bearing through all manner of disturbances, like Marine sentries at the White House, who have a track record of enduring unexpected conditions, all while maintaining their composure. Earlier this year, a group of Marine Corps body bearers serving on a funeral detail at Arlington National Cemetery waded into knee-deep flood waters in their Dress Blue uniforms to help a couple trapped in a stalled out car. Fortunately for the Tomb guards, hurricane season is not scheduled to begin for another six months.

NAVY CAPTAIN BECOMES 1ST WOMAN TO COMMAND US NUCLEAR CARRIER

AN DIEGO (AP) — The USS Abraham Lincoln deployed this week from San Diego under the command of Capt. Amy Bauernschmidt, the first woman to lead a nuclear carrier in U.S. Navy history.

Bauernschmidt, who previously served as the Abraham Lincoln's executive officer from 2016 to 2019, took over command from Capt. Walt Slaughter during a ceremony last August, <u>CBS 8</u> in San Diego reported.

The carrier deployed Monday from Naval Air Station North Island as part of the Abraham Lincoln Carrier Strike Group.

"There is no more humbling sense of responsibility than to know you are entrusted with the care of the people who have chosen to protect our nation," Bauernschmidt said, according to a Navy news release. "Thank you, Capt. Slaughter, for turning over the finest ship in the fleet."

Bauernschmidt previously served as the commanding officer of Helicopter Maritime Strike Squadron 70 and the amphibious transport dock San Diego.

She has completed more than 3,000 flight hours during her career, the news station reported.

The Abraham Lincoln completed its maintenance period in April, following a 294-day, around-the-world deployment.

The Carrier Strike Group is led by the command staff of Carrier Strike Group 3 and consists of Nimitz-class aircraft carrier USS Abraham Lincoln, Carrier Air Wing 9, the guided-missile cruiser USS Mobile Bay and the guided-missile destroyers of Destroyer Squadron 21 — USS Fitzgerald, USS Gridley, USS Sampson and USS Spruance.

The strike group is deploying with what the Navy is touting as its "most advanced air wing" and is heading to the Indo-Pacific region.

The first women to serve in the Navy were nurses in the early 20th century and the first large-scale enlistment of women came during World War II, according to an <u>official military history website</u>. The Navy designated the first woman as an aviator in 1974 and women were first assigned to a combat ship, the USS Dwight D.1 Eisenhower, in 1994.

SPECIAL PODCAST SERIES FOCUSES ON VETERAN SUICIDE

To kick off the third season of the Tango Alpha Lima podcast, The American Legion is focusing attention on identifying solutions for and raising awareness about veteran suicide. This special four-part series focuses on efforts by American Legion members around the United States that are having an impact.

The American Legion encourages you to share these episodes in the hope that they will spread awareness and find solutions to this ongoing crisis.

The <u>first episode was published on Jan. 4</u> and the other three episodes will follow each day this week. Here are the highlights of each episode:

Part One: American Legion Department of Idaho Adjutant Abe Abrahamson discusses the Idaho American Legion One More Day program. The suicide intervention program uses a peer-to-peer model to work with at-risk veterans. A team of three all have specific tasks to get the veteran help and then be available well after the initial 911 call. Abrahamson, the director of One More Day, believes this formula can be adapted elsewhere. "It may not be a cookie-cutter program for everybody," he said. Part Two: Air Force veteran Jeffrey Freeman credits The American Legion with saving his life after an attempted suicide. Freeman, a member of Post 190 in Ripon, Calif., was diagnosed with fibromyalgia nine years ago and struggled with being unable to work. After an argument with his wife, Freeman walked out of their home and intentionally into the path of a tractor-trailer. "I have no idea how he missed me," he recalled. About a month later, Freeman joined The American Legion, where he found camaraderie, and the opportunity to serve with a post honor guard. "It was a perfect fit for me," says the current adjutant of District 11. "It's given me a purpose, a meaning." Watch on YouTube or listen here.

Part Three: Sean Powers, a member of American Legion 9-11 Memorial Post 2001 in New York City,

discusses the New York Police Department's POPPA (Police Organization Providing Peer Assistance) program. Powers is among the volunteers with POPPA, a volunteer police support network committed to providing a confidential, safe and supportive environment for police officers and retirees. While POPPA, which began in 1996, is geared toward officers, the approach can be scaled to assist veterans who are struggling, Powers says. In fact, he has used his POPPA training to help veterans from the Global War on Terrorism, Vietnam and even World War II.

Part Four: Virginia Cruse, an Army Reserve officer and combat veteran, found herself on the brink during a deployment, which led her to returning to school to become a licensed professional counselor. Cruse, who works for Military Counseling Center San Antonio, now provides crisis intervention and evidence-based treatment for veterans suffering from PTSD, moral injury, depression and other diagnoses. "When you can see yourself the way others see you, the way loved ones see you, your whole world changes," said Cruse, an American Legion member of Post 145 in Bristol, Tenn. "And that is the goal of PTSD treatment."

#### Paid-Up-For-Life (PUFL) Agreement

- 1. The applicant must be in **good standing**.
- 2. National Headquarters reserves the right to require further information or confirmation of the member's eligibility, which may include a request for the member to provide a copy of his/her DD214 (or similar) or other documentation of age, military service or membership eligibility. The member's Paid-Up-For-Life application will be held pending verification.
- 3. The member's Post will be notified of the new PUFL membership and will be permitted up to 30 days to challenge the application for acceptance.
- 4. If payment is being made using a credit card, the full payment will be charged immediately. Payment can be made by MasterCard, Visa, Discover or American Express.
- 5. The permanent (plastic) PUFL card will be issued within 4-6 weeks of receipt and approval of the application.
- 6. No refund of payment(s) will be made if the member chooses to discontinue his/her PUFL membership at any time, once the application is approved and processed; the only exceptions are explained in Item 7. This also pertains to members participating in the Time Payment Plan whose account was closed due to delinquency. These members will not be eligible to participate in the Time Payment Plan in the future but may re-submit an application with full payment at any time. (Any funds previously submitted on the cancelled account will not be credited to the new application.)
- 7. Should a PUFL member hold membership in a Post whose charter has been canceled and no other Post is available to accept a transfer, then the unused portion of the original fee, if any, will be refunded. The same rule will apply in the event that the member is expelled from membership by action of his Post or Department Headquarters. Except as stated, no refund of any portion of PUFL membership fees paid to National will be made at any time.
- 8. Once the application is processed by National Headquarters, the member will no longer receive renewal notices and his/her subscription to The American Legion Magazine will never expire. The member will be automatically renewed each year and his/her annual membership card will be mailed around July 1st to the member's address on record at National Headquarters.

#### Additional Terms for Time Payment Plan Participants ONLY

- 1. Current members of The American Legion may use the Time Payment Plan to purchase a Paid-Up-For Life (PUFL) membership through National Headquarters. No Interest or service charge is added.
- After receipt and approval of the application at National Headquarters, the remaining balance will be divided into 11 equal monthly payments.
  - National Headquarters will bill the credit card account provided by the member each month in the amount of 1/12 of the total Paid-Up-For-Life fee.
  - It is the responsibility of the member to contact the PUFL Specialist at 800-433-3318 to report a new credit card expiration date prior to the expiration of the card information originally provided.
  - If the member wants to change the credit card account used at any time after the application is submitted to National Headquarters, the member must contact the PUFL Specialist at 800-433-3318 to provide the replacement credit card information.
- 3. The total PUFL membership fee must be paid within 12 months after the application is processed at National and consecutive monthly payments are to be maintained. Delinquent accounts may be closed with or without notice to the member. A delinquency will occur if the member's credit card payment is declined for any reason. Any payments already made will be forfeited; no refunds will be issued if a Time Payment account is closed for any reason.
- 4. The member can elect to pay more than the minimum each month; much the same as a credit card account, paying in advance, or more than the minimum, simply means the account is paid off earlier. To increase the monthly payment amount billed to the member's credit card, the member must contact the PUFL Specialist at 800-433-3318.
