# **Vets On The Water**

Vets On The Water is a nonprofit initiative that expresses our ongoing thanks and appreciation for the service and sacrifice given by our nation's veterans. Through the generous contributions from the following individuals, businesses and organizations, complimentary fishing, sailing and cruising opportunities were provided this past summer to more than 150 individual veterans.

Each Monday, weather permitting, Recreational Therapy Services at VA Maine Healthcare supported numerous veterans as they participated in the Vets on the Water program. Venues included Damariscotta, Rockland, Rockport and Camden Harbor. Each week veterans were greeted by a number of local volunteer skippers who provided a memorable day for the veterans in attendance on Maine lakes and in the beautiful waters of Penobscot Bay.

These generous and caring skippers made the program possible. Each boat had a health care professional on board and bag lunches — beverages were provided by local and state businesses. Fishing and cruising support was also provided to Embrace A Vet, Wavus Veterans Camps and the Travis Mills National Veteran's Family Center.

What's next? Ice fishing and related winter outdoor activities with ongoing support from our new friends at Camp Wavus and the Damariscotta Lake Watershed Association.

At this time, we are ice fishing on 3 Mile Pond, Vassalboro. Specific information is on our Facebook Site - Vets on the water. Commissioner Woodcock grants a Maine fishing license waiver for Service Connected Disabled Vets under the state's 50% threshold. Our warden service recommended 3 Mile Pond as having good ice and good fishing. Interested Vets can contact VA Recreation Therapy at Togus or call me at 542-3590.

We will be starting our open water program shortly after ice out and are going to be adding striper fishing on the Kennebec this summer - when the migration arrives.

We also have a fish house on loan to the Bangor VA outreach program. Contact them for info.

HealthNet Federal Services - Need to knows ~ Explanation of Benefits

Beneficiaries with HealthNet Federal Services (Tricare Prime Remote, Tricare Retired Reserve and Tricare Reserve Select) have their Explanation of Benefits (EOB) sent to their email address, if one is on file. Often these EOBs go to junk mail or spam. It is imperative that beneficiaries keep HealthNet appraised of their current email address and fix their email settings so HealthNet information will not go to spam. Here are some of the reasons:

- a. If a beneficiary does not respond to correspondence, the beneficiary may be disenrolled from their benefit, not enrolled as requested or become liable for payment of the claim.
- b. A claim may go to collections due to non-response by the beneficiary. It then becomes the beneficiary's sole responsibility to work with the collection agency.
- c. Within the next few months the company providing management of the Tricare benefit for the North Region will change from HealthNet to Humana. Information regarding the changeover and potential change of network providers may/will be sent via email. \*\*\*This DOES NOT affect Tricare beneficiaries enrolled in Martin's Point.

Tricare Young Adult Program ~ Do you have a child who is 21-23 and not in college? The Tricare Young Adult Program may fit the bill for their health care coverage.

Tricare Urgent Care Copays and Costshares ~ Did you know that some TRICARE Prime enrollees may be paying emergency room copays for urgent care visits. That's a big NOGO! The urgent care copay for Prime beneficiaries is \$12 for retirees and their eligible family members while active duty members and their families pay nothing for urgent care. TRICARE Standard beneficiaries still have a 25% cost-share for non-network and 20% cost-share for network visits.



# Two New Exhibitions Explore Maine's Wartime Experience

Maine Historical Society is launching two exhibitions illustrating the effects of war on the state of Maine and its people: **World War I & the Maine Experience** explores how communities around the state experienced, were devastated by and memorialized the First World War; **Veterans' Voices** features first--person stories from veterans spanning World War II to Afghanistan.

# World War I & the Maine Experience | Opens to the public Friday, February 3

Known as "The War to End All Wars," World War I ended nothing. 2017 marks the 100th Anniversary of American involvement in the First World War, and an opportunity to reflect on the tremendous impact it continues to have on American politics, society and culture. Our exhibition, World War I & the Maine Experience places emphasis on Maine's attitude towards the conflict, the cultural rhetoric of the period, and the service and sacrifice of Maine citizens on the front and at home.

The exhibition also explores the role the media played in public opinion, and highlights how Maine's economy, population and development reflected and reacted to the global issues at hand. Through exhibited objects including posters, pamphlets and political cartoons, the exhibition depicts a nation rallying together to support its allies and "preserve liberty." Also on view are uniforms and period clothing, military documents and weaponry including a ca. 1895 Colt--Browning machine gun, as well as a rich collection of photographs and letters demonstrating the veteran experience, the complexities of reintegration and the comradery of service.

# **Veterans' Voices** | Opens to the public Thursday, January 12

There are approximately 127,000 veterans living in Maine today, and their histories are as diverse as their backgrounds. Veterans' Voices shares first--person stories from Maine veterans – all ordinary people who have done extraordinary things in trying times.

"While we might think we know about veterans' service, full of combat and heroism, the personal histories of people who served in the military are often more nuanced and humble," said the exhibition's curator Tilly Laskey, outreach curator at MHS. "Many of the veterans' stories contain difficult memories, and recounting them is a brave and emotional experience."
